A-Z INFORMATION JAMAICA LIMITED AWARDED RESEARCH TENDER FOR CCJ

Port of Spain, Trinidad and Tobago. A-Z Information Jamaica Limited has been awarded the tender under the CARICOM Secretariat, Procurement Unit to execute a regional Knowledge, Perceptions and Attitudes survey on behalf of the Caribbean Court of Justice (CCJ). This project is funded by the 11th European Development Fund. Under the management of Dr Noel Watson, A-Z Information Jamaica Limited is a dynamic company with a wealth of expertise in the application of state of the art approaches in research and marketing, management, and business process improvement, among other strategic areas.

With a proven track record in regional and international projects, A-Z will be instrumental in providing keen insights over the next seven to ten months that align with the CCJ's 2019-2024 Strategic Issue 1: Communication. The purpose of this contract is to develop and conduct a regional baseline survey to ascertain the Key Performance Areas (KPAs) of individuals and organisations, both judicial and non-judicial. This survey will focus on key issues related to the role and function of the CCJ, including awareness and understanding of the organisation. The results of this survey will contribute to the understanding of the acceptance of the CCJ within the CARICOM region. The survey will then be used by A-Z to design and conceptualise the necessary specific public education initiatives and activities aimed at strengthening the functions and outreach of the CCJ.

Following these interventions, which shall be implemented by a separate consultant, a post-intervention survey shall be carried out to assess changes and provide insight into the impact the public education interventions have had, comparing baseline and end-line data against the indicators set during implementation of the baseline survey. This post-intervention survey shall highlight significant and important findings that may inform future similar actions and will establish a new baseline for developing further public education initiatives.

About the Caribbean Court of Justice:

The Caribbean Court of Justice (CCJ) was inaugurated in Port of Spain, Republic of Trinidad and Tobago on 16 April 2005 and presently has a Bench of six judges presided over by CCJ President, the Honourable Mr Justice Adrian Saunders. The CCJ has an Original and an Appellate Jurisdiction and is effectively, therefore, two courts in one. In its Original Jurisdiction, it is an international court with exclusive jurisdiction to interpret and apply the rules set out in the Revised Treaty of Chaguaramas (RTC) and to decide disputes arising under it. The RTC established the Caribbean Community (CARICOM) and the CARICOM Single Market and Economy (CSME). In its Original Jurisdiction, the CCJ is critical to the CSME and all 12 Member States which belong to the CSME (including their citizens, businesses, and governments) can access the Court's Original Jurisdiction to protect their rights under the RTC. In its Appellate Jurisdiction, the CCJ is the final court of appeal for criminal and civil matters for those countries in the Caribbean that alter their national Constitutions to enable the CCJ to perform that role. At present, four states access the Court in its Appellate Jurisdiction, these being Barbados, Belize, Dominica, Guyana, and Saint Lucia. However, by signing and ratifying the Agreement Establishing the Caribbean Court of Justice, Member States of the Community have demonstrated a commitment to making the CCJ their final court of appeal. The Court is the realisation of a vision of our ancestors, an expression of independence and a signal of the region's coming of age.
